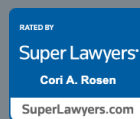

Rosen's practice focuses on counseling clients regarding compliance with the Americans with Disabilities Act, 42 U.S.C. 12101 (the "ADA"), the Fair Housing Act, 42 U.S.C.A. §§ 3604 and 3605 (the "FHA"), the New York State Human Rights Law, Exec. Law § 296 (the "State Human Rights Law"), Section 8 of the Administrative Code of the City of New York (the "City Code", together with the ADA, FHA, and State Human Rights Law, the "Human Rights Laws"). Rosen has a keen understanding of the nuances of this evolving regulatory landscape which she utilizes to, not only defend administrative and civil proceedings alleging discrimination, but counsel real estate professionals and organizations on best practices. Rosen has drafted policies and procedures for compliance with the Human Rights Laws for several major developers in New York. These procedures include appropriate policies for (i) implementing features of accessible design, (ii) ensuring compliance with the Human Rights Laws throughout development of real properties, (iii) review of tenant applications and consideration of source of income and criminal history information in assessing the same, (iv) responding to requests for reasonable accommodations to policies and practices (i.e. requests related to service and emotional support animals) and reasonable modifications to the features of accessible design, (v) overseeing remediation of properties to meet accessibility requirements and (vi) the education and training on applicable legal requirements.

In the context of her practice, Rosen handles Federal litigations throughout the United States, brought by private complainants, the United States Attorneys' Office and State Attorney Generals. Rosen has successfully defended administrative proceedings and investigations commenced by the New York City Commission on Human Rights and the New York State Division of Human Rights. Rosen has also developed novel and creative strategies for compliance with the Human Rights Laws, including working alongside engineers to create innovative adaptable design features for use at her client's properties.

Additionally, Rosen has secured numerous favorable outcomes on behalf of New York City's leading property owners, showcasing a level of expertise and dedication that truly sets her apart. istrative proceedings alleging that nationally recognized housing providers have discriminated on the basis of age, color, creed, disability, familial status, lawful source of income, marital status, national origin and partnership status, and (ii) a petition seeking penalties, injunctive relief and damages for alleged inaccessible conditions and discriminatory business practices and a nationally recognized multi-purpose indoor entertainment arena in New York City.

- Other notable representations include, but are not limited to:
  - *S&P Associates of New York LLC v Jerome Dewald et al.*, Index No. 159779. Secured the first court order prohibiting Airbnb and a New York City tenant from listing the tenant's apartment on online platforms, in violation of Local Law 18, which prohibits the short-term rental of unregistered apartments in New York City.
  - *FC 42nd Street Associates, L.P. v 42nd Apple, LLC*, 0656904/2021. By decision and order dated September 23, 2022 the Hon. Lucy Billings, J.S.C. granted Rosenberg & Estis's motion for summary judgment, awarding its client use and occupancy in excess of six million dollars, statutory interest, and attorneys' fees and costs, along with an order of ejectment. The court held that the tenant, one of the approximate 29 franchise locations operated under the management umbrella of Apple Metro Inc., the largest New York Metropolitan Area franchisee of Applebee's Neighborhood Grill & Bar, wrongfully withheld rent and use and occupancy at its Times Square location, rejecting contentions that the Covid-19 pandemic frustrated the purpose of the subject lease, rendering performance thereunder impossible, and that temporary government restrictions on restaurant operations during the pandemic entitled it to a rent abatement.
  - *Schrader v Lichter Real Estate Number One, L.L.C.*, 156305/2016. By decision and order dated July 29, 2020, the Hon. Barbara Jaffee, J.S.C. granted Rosenberg & Estis's motion for summary judgment dismissing tenants' complaint for rent overcharges and holding that the conduct alleged – failure to offer rent stabilized leases, renewals, and lease riders, and to register the apartments with DHCR – is insufficient to establish fraud, and referable to owners' belief that it was entitled to rely on the then existing DHCR guidance and regulations.
  - *Kessler v Carnegie Park Assoc., L.P.*, 2017 N.Y. Slip Op. 31445(U), 1 (N.Y. Sup Ct, New York County 2017), *aff'd sub nom. Kessler v HFZ 90 Lexington Ave. Owners LLC*, 2019 N.Y. Slip Op. 00075 (1st Dept 2019). Obtained decision, as affirmed on appeal, by the Appellate Division, 1st Department, dismissing a class action complaint seeking to recover punitive and treble damages under the General Business Law against owners of several Manhattan residential buildings converted to cooperatives or condominiums (see <https://www.rosenberg-estis.com/practice-areas/litigation/litigation-department-news/beverly-kessler-v-hfz-90-lexington-avenue-owners-llc-carnegie-park-associates-l-p/>).
  - Handled rent reset arbitration for a well-known New York City restaurant chain, resulting in a multi-million-dollar reduction in commercial rent.

building in the burgeoning Nomad neighborhood, resulting in a more than \$10 million dollar increase in the valuation and fiscal distribution to withdrawing shareholder.
